- 1. Identified group agreements
  - Inclusiveness with respect to access to funds
  - Value a range of opinions
  - It's ok to disagree
  - Make space, take space
  - Verbally acknowledge bias to help be as objective as possible. Full disclosure is important.
  - Safe space for open dialogue
  - Enough, let's move on (ELMO)
  - Start on Berkeley time
  - Decision making: 50% + 1
  - Proxy system for voting
- 2. Discussed Student Services Fee (SSF)
  - This fee typically supports career, health and well-being, social, cultural, recreational, campus life and equity and inclusion programs. The annual report for FY14-15 is at: <u>http://budget.berkeley.edu/sites/default/files/FY14-15%20Stdt%20Svcs%20Fee%20Rpt%20-%20Berkeley.pdf</u>.
  - The SSF has seen little increase while the cost of tuition has steadily climbed. A document of the historical fee levels was shared. It was also noted that the SSF increased by 5% this year (an incremental increase). Per UCOP, one-third will go to financial aid, one-third to student mental health services geared specifically to increasing access and reducing wait times, and one-third to other critical student services. The approximate increase for each of these three areas is \$580,000. CACSSF will make recommendations on the other critical student services.
  - Decision-making authority: CACSSF for the discretionary fund and the Chancellor for the incremental increase.
  - CACSSF revised its Student Services Fee funding values. Thanks to Jenna who categorized them.

Substantive Values

- Has a large impact for a small population, especially an underserved population (e.g., Dreamers Resource Center)
- o Reaches a very large number of students
- $\circ$  ~ Is a new service on campus that is unique and different and addresses a student need
- o Has a lasting impacting (e.g., one-time funding for student space improvement)
- Develops a foundation or allows structural change that has a long term impact even if it doesn't impact students directly (e.g., ASUC Auxiliary Transition Implementation Manager)
- o Projects that are holistic and multidimensional address multiple parts of a student's life
- o Address holistic health and wellness issues, especially mental health issues
- Student-led effort that provides opportunities for student empowerment, capacitybuilding or leadership

- Promotes or enhances the diversity of our campus, especially with regards to minority and disadvantaged communities
- We value programs that appeal to both undergraduate and graduate students as well as programs that meet the unique needs of graduate students.

Process and Sustainability Values

- Makes good use of resources
- Sustainability: confidence that the program/service can continue
- o Capacity for requestor(s) to evaluate the effectiveness of the event/program/service
- Holistic look at requestor(s) to see if appropriate
- o Collaborative efforts across departments and with students
- Level and appropriateness of student consultation
- CACSSF reviewed the fall 2015 timeline and proposal process for the discretionary fund. The committee also identified questions and principles to guide a committee workgroup charged with proposing a proposal process for the incremental increase for critical student services. The workgroup will include Jenna, Melissa, Fabrizio, Liz and Bene.
